Minutes of Regular Meeting July 15th, 2021

CALL TO ORDER: Ken Schein, Commissioner, declared a quorum and called the meeting to order at 4:00 pm. Other commissioners present were: Jim Whitcomb and Archie Dishman. Also present was Fire Chief Darren Brinkkoeter, Assistant Fire Chief Robert Mikel, EMS Division Chief Chris Clapper and Angela Hemphill, Chief Financial Officer. Commissioner Crossan and Hays were not in attendance.

APPROVE/DISAPPROVE MINUTES OF PREVIOUS MEETING: The minutes of the regular meeting on June 17th had been emailed prior to the meeting. A change was requested. **The board accepted the revised regular minutes as proposed**.

CITIZEN'S COMMENT:

No Citizens were present at this meeting.

CHIEF's REPORT: Fire Chief Darren Brinkkoeter summarized the report distributed. Chief Chris Clapper summarized the report submitted by Juanita Alexander, CHPP Paramedic. Ms. Hemphill stated that the Canyon Lake Fire/EMS, Inc. board of directors met to discuss the status of the Community Health Paramedic Program (CHPP). It was decided by this board that the program has had to change significantly due to COVID19 along with capturing revenue sources that could make the program self-sufficient are not foreseeable. The board opted to discontinue the program effective 10/1/2021. Chief Brinkkoeter informed the board that the County is reporting an increased in the COVID19 cases. The board acknowledged the report as given.

CONSIDER, DISCUSS AND TAKE APPROPRIATE ACTION ON PROPOSED CLINICAL AFFILIATION. AGREEMENT BETWEEN COMAL COUNTY ESD 2, ESD 3 AND TEXAS LUTHERN UNIVERSITY:

CONSIDER, DISCUSS AND TAKE APPROPRIATE ACTION ON BUDGET FORMULATION FOR FY22 BUDGET BASED ON ESTIMATED FUTURE TAX REVENUE BASED ON THE APPRAISAL DISTRICT ASSESSMENTS AND FUTURE REQUIREMENTS:

Ms. Hemphill stated that she along with the Chiefs are finalizing the proposed FY22 budget. The appraisal district has until July 25th to certify numbers. Once we have those numbers we can determine what the proposed tax rate will be for 2021. She recommended holding the budget workshop early August. Since Fran and Tom were not in attendance, Ms. Hemphill stated she would confirm availability for a date and send back out to the board.

Commissioner Hays was not in attendance to this meeting. Commissioner Whitcomb ask that the committee or Leadership staff consider holding Open Houses soon for the two new stations.
