# COMAL COUNTY EMERGENCY SERVICES DISTRICT No. 2 MINUTES of September 12<sup>th</sup>, 2019 Special Meeting

#### TAKE RECORD VOTE ON THE APPROVAL OF THE PROPOSED 2020 FISCAL BUDGET:

Mrs. Hemphill stated that there have been no additional changes outside of the ones discussed and agreed to at the budget workshop in early August. ## TAKE RECORD VOTE ON THE DISTRICT'S 2019 TAX RATE, ADOPT AN ORDER LEVYING TAXES AND AUTHORIZE FILING THE ORDER WITH THE COMAL COUNTY TAX ASSESSOR-COLLECTOR:

Commissioner Whitcomb stated that the tax rate necessary to fund the 2020 budget is \$.08 cents per \$100 valuation. Commissioner Whitcomb requested a record vote be made related to the adoption of the proposed order to levy taxes at a rate of \$.08/\$100 valuation and authorization to file the order with the Comal County Tax Assessor-Collector:

All commissioners approved, motion carried.

### **Commissioners Comments:**
