### Minutes of Regular Meeting February 27th, 2020

**CALL TO ORDER**: Tom Crossan, Commissioner, declared a quorum and called the meeting to order at 6:30 pm at Canyon Lake Fire/EMS Station 51, 1074 Scissortail, Canyon Lake, Texas. Other commissioners present were: Jim Whitcomb, Francesca Hays, Kenneth Schein and Archie Dishman. Also present was EMS Division Chief Brandon Kludt, Fire Chief Darren Brinkkoeter, Assistant Fire Chief Robert Mikel and Business Manager Angela Hemphill.

**APPROVE/DISAPPROVE MINUTES OF PREVIOUS MEETING:** The minutes of the regular meeting on January 16<sup>th</sup> had been emailed prior to the meeting. No changes/corrections were requested. **The board accepted the proposed minutes as presented**.

#### **CITIZEN'S COMMENT:**

There were no citizens present.

**CHIEF's REPORT:** EMS Division Chief Kludt informed the board that there were 225 EMS calls for service for the month of January. The average response time was 7:41. The board and Chief Kludt discussed the remainder of the report. The board acknowledged the report as given. Chief Kludt updated the board on the current state of our region related to the Coronavirus (COVID19).

## REVIEW, DISCUSS AND TAKE APPROPRIATE ACTION ON INTENT TO PURCHASE 2020 FORD F450 TYPE I 14' AMBULANCE FROM STERLING MCCALL FORD/FRAZER TOTALING \$289,885.07:

Chief Kludt presented the specifications for the unit being proposed and stated that this item is within the 2020 budget. Commissioner Whitcomb moved to approve the proposed Intent to Purchase the 2020 Ford F450 Type I 14' Ambulance from Sterling McCall / Frazer totaling \$289,885.07. Commissioner Dishman seconded and all commissioners approved.

### CONSIDER, DISCUSS AND TAKE APPROPRIATE ACTION ON PROPOSED SERVICE AGREEMENT BETWEEN COMAL COUNTY ESD No. 2, COMAL COUNTY ESD No. 3 AND KONA COAST VENTURES (WWA):

Mrs. Hemphill stated that the Form 1295's have not been filed by the business entity and requested that we table this item until the March meeting. The board and Chiefs discussed considering a price increase if there was going to be discussion of a multi-year agreement.

## CONSIDER, DISCUSS AND TAKE APPROPRIATE ACTION ON PROPOSED SERVICE AGREEMENT BETWEEN COMAL COUNTY ESD No. 2 AND ELEANOR PRESTON FOR 2020 BOOKKEEPING SERVICES:

Mrs. Hemphill stated that there were no changes outside of dates included in the agreement and that Ms. Preston appreciates the opportunity to work for the board again if they would like her to. Commissioner Dishman moved to approve the proposed service agreement between Comal County ESD No. 2 and Eleanor Preston for 2020 Bookkeeping Services. Commissioner Schein seconded and all commissioners approved.
